### VENDOR POLICY AND REGISTRATION

You are cordially invited to attend the American Coach Association Spring National Rally to be held May 27-31, 2010 at the Cam-Plex in Gillette, WY. This event marks the 20<sup>th</sup> Anniversary of the America Coach Association and we would welcome your participation in helping us celebrate this momentous occasion. If you should choose to attend, please fill out the vendor registration page, enclose the total vendor fee amount and mail to Ron Haworth at the address shown, no later than May 1, 2010. All parking spaces are full service.

### VENDOR POLICY

1. We welcome all vendors to attend the ACA Spring National Rally and to display their products and present seminars.
2. Days and hours of vendor operation are as follows:

Thursday, May 27	1 PM - 4 PM	Friday, May 28	9 AM - 4:30 PM
Saturday, May 29	11 AM - 4 PM	Sunday, May 30	9 AM - 4 PM
3. VENDOR FEE
  - a. Vendors that are American Coach Owners may register online and pay the regular attendee rally fee of \$335.00. In addition, a vendor fee of \$ 75.00 is to be mailed to Ron Haworth.
  - b. Vendors that are not American Coach Owners must pay a vendor fee of \$ 125.00. Those wishing to partake in meals and entertainment are required to pay a rally registration fee of \$80.00 per person and \$21.40 per night camping fee.
  - c. The vendor registration fee is based on a Standard Vendor Booth which consists of:
    - (1) Standard 10 X 10 display area
    - (2) Tables and chairs
    - (3) Draping
    - (4) Electrical
  - d. Extra cost booth items, consist of:
    - (1) Additional 10'x10' booth display area
    - (2) Internet connection
    - (3) Anything not listed in the Standard Booth
4. Vendors that require motel/hotel accommodations must make their own reservations, Gillette has many fine choices.
5. Registered rally attendees will not be permitted to vend from their motor homes unless parked in a vendor designated area and have paid the required vendor fees.
6. Vendors will be mailed a confirmation notice, an Agenda and placard with name, which will be displayed in the lower left corner of the driver's windshield.

8. Vendors may arrive a day early. Set up time will be from 1-4, May 26 and 8-12, May 27.
